67<sup>th</sup> ANNUAL WOMENS NUUSBCA TOURNAMENT RULES  
THIS WILL BE AN ALL WOMAN TOURNAMENT

All bowlers must report one-half hour before their scheduled squad time

1. Entry will be open to all female members of the Northern Utah USBC Association.
2. **USBC Tournament rules shall govern this tournament.**
3. The tournament shall consist of a four-woman team event, a singles event, a doubles event, and an all events. Three consecutive games shall be bowled in each event and total pins shall decide the winner.
4. This is a handicap tournament. **Handicap will be based on 100% of 225.** Entrant will use their highest 2006-2007 NUUSBCA book average.
  - ◆ If there is no 2006-2007 book average, current average with a minimum of 12 games as of October 24, 2007
  - ◆ All others must bowl scratch. The entrant must use her highest average whether bowled as regular member of a league or as a substitute. If an entrant is using a current season average, a verified average must accompany the entry or the entrant must bowl scratch. USBC rules 319 D and 319 E are waived for this tournament.
5. **Entries open October 3, 2007. Preferred entries must be postmarked no later than midnight, Wednesday, October 24, 2007. Re-entry's (walk-ins) will be allowed up to 1 hour prior to last squad, lane availability permitting.**
6. **\*\*Bowlers who for health reasons cannot bowl singles and doubles (6 games) at one squad time may request separate squad times for these events. Request for this privilege must be submitted with entry form.\*\***
7. An entrant may participate in the team event more than once, however not more than three bowlers on one team can place more than once in the prize list for position standing. Substitutes and women from sanctioned mixed leagues are eligible to make up a team. An entrant who bowls singles, must also bowl doubles. An entrant who bowls doubles, must also bowl singles.
8. When a bowler competes more than once, her first appearance in each event shall count towards her all events score, which is the total of her team, singles and doubles scores.
9. Substitutes are allowed when replacement is necessary. The Tournament Manager must be advised of all subs. In case of an emergency after a game(s) has started, a substitute, if one is available, shall be allowed in the team and/or doubles. If no substitute is available, only the actual scores of the frames bowled will count.
10. A substitute will not be required to reimburse the original entrant for the entry paid, nor shall the substitute expected to get any prize money or award she may win.
11. Disorderly conduct of any kind may disqualify the bowler. An individual may be the cause of disqualification of all members on a team or her doubles partner.
12. In case of first place ties for any event, CO-CHAMPIONS WILL BE DECLARED. If a tie occurs, prize money will be combined and divided equally among the tied position winners.
13. The Board of Directors of the Northern Utah USBC Association shall decide any questions and or disputes not governed by these tournament rules.
14. **THERE WILL BE NO FORM OF GAMBLING WHILE BOWLING IN THE TOURNAMENT.** Brackets and card games do not constitute gambling per USBC rule 15
15. Entrants whose names appear hereon or their authorized replacement hereby agree that the Northern Utah USBC Association, its officers and agents shall be liable only to the extent of returning entry fees, if, and when these entrants shall be prevented from bowling any event in the tournament through delay, unexpected yet necessary schedule change or premature termination of the tournament which may be brought about by war, national emergencies or emergencies or causes relating thereto, or emergencies resulting from fires, strikes, lockouts, labor disputes or other causes beyond the control of the Northern Utah USBC Association.
16. **Dress Code:** No spaghetti strap blouses, shirts or tank tops, Shorts must be at finger-tip length or longer with arms at sides.
