TOURNAMENT RULES 2009

PLEASE READ THE FOLLOWING INFORMATION CAREFULLY

The GOLDEN SPIKE HANDICAP BOWLING TOURNAMENT is open to members of Sanctioned Leagues. All participants must have a current USBC CARD. **Unattached membership cards** are \$21.00. Participation Fee is \$5.00.

EVERYONE IS INVITED TO PARTICIPATE

This is NOT a mixed Tournament. Teams will consist of 5 men or 5 women. Doubles will consist of 2 men or 2 women.

A bowler may enter the team event **two (2) times only**. First appearance will count towards All Events. A team who uses a bowler who has already bowled twice in team events, in this tournament will forfeit any games in which the bowler participates with that team.

Not more than 3 players on the same team can bowl together or place more than once on a prize list. A bowler may enter doubles and singles **only once**. If singles are bowled, doubles must also be bowled and visa versa.

Team Captains will be held responsible for making any average correction and making sure any substitutes are advised and understand the rules and are eligible to bowl. Tournament Secretary or designated Committee member must be notified of substitutions at least 30 minutes before event is scheduled to begin.

Bowlers will use highest 2007-2008 yearbook average, as reported to USBC. This will include summer average. If no 2007-2008 yearbook averages use current average as of February 1, 2009. All others bowl scratch. Bowlers must have at least 21 games bowled with league from which entered. It shall be each bowler's responsibility to verify the accuracy of his average whether submitted by the bowler himself or his team captain.

Bowlers are responsible for verifying his/her average, whether submitted by the bowler, the team captain or others. If a bowler's current average at the time of entry (February 1, 2009) is 10 pins higher than the 2007-2008 yearbook average, the bowler must use his current average for entry in tournament. Rule 319a item 3 penalty for reporting incorrect averages will apply.

Handicap will be 90% of the difference between average and 230. **NO MAXIMUM.**

Rerating requirements (Rule 319c) USBC RULEBOOK will be used for all participants.

Bowlers will not be required to report winnings from other tournaments. Rule 319e will be waived.

Out of town bowlers must bring verification of average as of February 1st, 2009.

DRESS CODE: Shirts with sleeves. Long pants or shorts that are fingertip length. **NO cutoffs.**

Everyone entering tournament must agree to abide by rules and regulations of this tournament and USBC rules.
