TOURNAMENT RULES

ALL BOWLERS MUST REPORT ONE-HALF HOUR BEFORE SQUAD TIME

- FAILURE TO SHOW CORRECT AVERAGE WILL DISQUALIFY THE BOWLER AND ALL PRIZE MONEY WILL BE FORFEITED.** This is an actual pin fall (scratch) tournament. To participate in this tournament each bowler must have a current USBC membership card. Non-Northern Utah USBC Association members may pay a \$9.00 fee to become a member of the Northern Utah USBC Association.
- All prize fees will be returned 100% within each division, at a ratio of at least one prize for each eight entries or major fraction thereof.
- All Events will be bowler's 1st 3 games of Team Event and Singles Event – 100% prize fund returned for All Events
- Bowlers may participate in the three-person team event as a member of more than one team, only under the following condition:
 - No more than two players can compete together more than once in the three-person team event.
- There will be two divisions: 599 average and below, 600 average and above. The average will be based on bowler's highest established 2024-25 USBC composite average. If no previous 2024-25 composite average listed at USBC, use highest current of 21 games or more as of APRIL 11, 2026. Tournament Manager will not verify averages unless a bowler cashes in an event. If a tie occurs for the Championship, multiple championships will be declared.
- It shall be each bowler's responsibility to verify the accuracy of their average, whether submitted by the bowler or the team captain or others. Failure to use the proper average shall disqualify score if submitted average is lower than actual average thereby resulting in a lower classification. Correction of averages can be made up to the completion of the first game. Tournament prize winnings must be reported following USBC Rule 319-C, D and E. 2025-26 USBC Playing Rules Book will be used.
- Dress Code: All participants (men & women) may wear casual slacks, trousers, jeans, fingertip length shorts, skirts or skorts. Participants must wear a shirt with sleeves.
Unacceptable attire includes, but is not limited to: Tank tops, halter tops, bare midriffs, spaghetti strap tops, etc., not clean or in poor condition. Attire with inappropriate questionable, or offensive language or graphics. Bowlers will be required to change if attire is deemed inappropriate by tournament management or designee. Tournament management or designee decisions will be final.
